***Mr. Nazrul Islam***  
***Former Managing Director, IIFC***

Mr. Nazrul Islam, former Managing Director of Infrastructure Investment Facilitation Company. He obtained BSc Eng. from Bangladesh University of Engineering & Technology (BUET) in 1974 and MS in Engineering from University of Hawaii, USA in 1984.

Mr. Islam is one of the leading power infrastructure experts in the world, specializing in thermal technologies. Out of his 36 years of overall experience, he has 32 years of IPP and PPP experience in Asia, Pacific and Africa. He has worked in PPP assignments in more than 14 countries including Bangladesh, Kenya, Nigeria, Indonesia, New Zealand, Cook Islands, Rwanda, India, Pakistan, Sri Lanka, Philippines, Sierra Leone, Hong Kong, Malaysia, China and Solomon Islands.

Mr. Islam has been involved in IPP & PPP assignments worth over US\$ 20 billion in capital investment in the power sector, ports sector, roads sector, telecommunications sector, land ports and economic zones sector. He has experience of 35 PPP transactions, 55 PPP Projects development and 10 PPP related policy and guidelines formulation. He has been involved in over 100 public private partnership (PPP training) and capacity building workshops.

He contributed valuable roles in the formulation of the captive power policy, remote area power supply systems (RAPSS) Policy, grid open access, coal policy, Private Sector Infrastructure Guidelines and Economic Zones Policy.

Before Bangladesh (1988 to 1997), he worked for nine years as a power sector international consultant with the Electricity Corporation of New Zealand, the main Government utility in New Zealand at the time, as Group Manager, Project Development. In this position, he was responsible for developing a number of BOT and BOO power generation projects in the Philippines, Indonesia, India, China and other countries. He is conversant with all types of power generation technologies such as combined cycles, coal fired power stations, reciprocating engines, geothermal power stations, hydropower, combined heat and power and renewable energy. He specializes in contracts, contractual frameworks, negotiations and financial modeling.

He has recently led a team of IIFC experts in several Economic Zones PPP Projects. In the area of capacity development, he has been providing training of PPP to senior officials in the public and private sector for over 18 years. He was the Team Leader in ERD's capacity development study for five ministries including the Power Division. He was also the PPP resource person in SEIP's large training initiative. In the CBISP project, he was the Programme Coordinator and Key Expert No. 2 for Training of Trainers (TOT) and development the draft Power Sector Training Policy.



***Mr. Muhammad Shamsur Rahman***

Mr. Rahman is an Executive Director (Physical Infrastructure) of Infrastructure Investment Facilitation Company. He obtained his engineering degree from Bangladesh University of Engineering and Technology (BUET) in 1988, Masters in Business Administration (MBA) from the Institute of Business Administration of Dhaka University in 1994, Postgraduate Diploma in Islamic Banking and Insurance from UK and Chartered Financial Analyst (CFA) Level I from CFA Institute, USA in 2000.

Mr. Rahman is one of the pioneers who made the government and private sector stakeholders aware of the PPP potentials in Bangladesh. He has been serving as a PPP Expert for the last 19 years. He possesses an attractive combination of commercial and PPP skill. He contributed significantly in more than 40 PPP projects. He has a multidisciplinary experience with a diverse set of skills in PPP capacity development, policy development, institutional reform, regulatory framework development, PPP commercial analysis and model preparation, risk analysis, enterprise restructuring etc.



***Mr. Md. Faruque Hossain***  
***Senior Advisor, USAID Health Systems for TB (HS4TB)***

Presently Md. Faruque Hossain is working as Senior Advisor of USAID Health Systems for TB (HS4TB). He is a retired Secretary of the Government of Bangladesh and former Executive Chairman of National Skills Development Authority (NSDA), under PMO of Bangladesh. Before joining in Skills Development Authority, he was Director General (Additional Secretary) of Central Procurement technical Unit (CPTU) of Implementation Monitoring and Evaluation Division, Ministry of Planning, government of Bangladesh. As the Head of public procurement in Bangladesh, he has been carrying out necessary oversight functions of CPTU, covering legislation, procedures, capacity building, professionalization, and monitoring. He was also the administrator of the National Central Portal conducting electronic government procurement (e-GP) in Bangladesh.

As the DG, CPTU, Mr. Hossain has steered the management of Electronic Government Procurement Portal and implementation of e-GP that registered a spectacular growth in both value and volume over his tenure in CPTU. The e-GP in Bangladesh is presently a leading model among the countries implementing electronic means of Tendering in the world. He was also Chairperson of South Asia Public Procurement Network (SAPPN), a network of south Asian countries on public procurement.

Before joining CPTU he was head (joint secretary) of Public-Private Partnership Unit (PPP Unit) from 2011 to 2014 while he played the key role to develop PPP frame work including establishment of PPP Authority and Bangladesh Infrastructure Finance Fund Limited (BIFFL) in Bangladesh as institutional and financing framework for PPP. He worked closely with all the ministries in facilitating the Public - Private Partnership initiative.

Mr. Hossain is a certified National Trainer of public procurement, and a qualified resource person of the Chartered Institute of Procurement and Supply, UK, and a trainer of Public- Private Partnership. As a member of the Bangladesh Civil Service Administration, he worked in various Ministries as well as at the field level, having wide experiences in project facilitation, preparation, and implementation and monitoring with active role in procurement management.

Having his MSC in soil science in 1983 from the University of Dhaka, Mr. Hossain also completed MBA in 2005 and Masters in Public Procurement Management for Sustainable Development from Turin School of Business, Turin University in 2014. He obtained certification on Public- Private Partnership (PPP) from IP3 @Washington, USA, and PAI, London, UK. He also has achieved Diploma in

Developing Economies from IDE Advanced School, Japan. His publication, “Paradigm shift in Public Procurement to Public-Private Partnership Procurement in Bangladesh: Challenges Behind the scene” is a remarkable PPP analysis among his credibility.

Much to his credit, Mr. Hossain is well known in the literary circle of Bangladesh for his insightful rhymes. He is renowned for his works in children and juvenile literature and regarded in high esteem for his rhymes, stories, articles, features and travel tales for more than the last forty years. He has, to his credit, as many as 60 titles in different areas of literature. Mr. Md. Abul Bashar is a Joint Secretary of the Government of Bangladesh and currently acting as the Director General (DG) at Public Private Partnership (PPP) Authority under the Prime Minister’s Office. At PPP Authority, Mr. Bashar is the in-charge for all PPP investment promotion activities and national PPP Capacity Building Program. He also leads the PPP Technical Assistance component of the national PPP Budget of Bangladesh. Mr. Bashar took lead role in developing numbers of PPP projects in port, tourism and health care projects of which the Hemodialysis PPP project has been appreciated as the one of the top 100 PPP projects by KPMG in 2015. He is working PPP Authority from 2012 to till.

Before joining at PPP Authority, he served in the Ministry of Agriculture and Ministry of Public Administration. He attained his B. COM. Management (Hon’s) degree and Masters in Management from the University of Dhaka. Md.
